# ...LAS PALMAS UPDATE ...

The voice of the people was heard. On Aug. 30, the City Council voted (8-4 margin) to DENY THE DRIVEWAY ONTO LAS PALMAS from that monstrosity. Accordingly the Council directed the Board of Public Works to rescind the driveway permit.

The Board of Public Works voted 4-1 to comply (Comm. Hall voted with the developers). A letter from senior engineer King was drafted; the boys from Encino have 3 weeks to restore the curb & remove the driveway.

Peggy Stevenson drafted a resolution to remove PEDESTRIAN ACCESS from Las Palmas; she introducted it TUE. SEPT. 27 - it passed City Council by UNANIMOUS VOTE. The resolution directs the City Attorney and the Dept. of Bldg. & Safety to draft an ordinance removing pedestrian access to the apartments from Las


### IN REMEMBRANCE

## PRESIDENT'S COLUMN

Let's talk about the Las Palmas affair. As most of you know, the City Council voted on Aug. 30th by a vote of 8-4 to revoke the driveway permit at 2039 N. Las Palmas. They instructed the Board of Public Works and the City Engineer to revoke the permit and the Board of Public Works complied on Sept. 1st. In the last week of Sept., Councilwoman Stevenson introduced a motion in City Council to deny the development any lobby or pedestrian access to N. Las Palmas. This motion was carried by a unanimous vote of 11-0. The City Engineer and the City Attorney have been instructed to draft an ordinance prohibiting pedestrian access that must then be adopted by the City Council.

We are not completely out of the woods yet, but light is at least all around us.

Congratulations to those of you who helped make this hard won victory a reality. I hope you will accept the heartfelt thanks of the entire association and the appreciation of the residents of Las Palmas, Bon Air and Milner Road, who would have borne the brunt of the traffic and parking nightmare of the project.

Many of you were able to support the effort by letter writing and attending a hearing. There was a group that seemed to cover all the critical bases. They attended almost all of the hearings, called their neighbors, gave rides, demonstrated and contributed funds. This group came from all parts of the hill and I want to express my deepest appreciation to them. This group seemed to realize the full implication of the proposed intrusion, which seriously threatened our Closure project and a better quality of life!

Our legal defense fund was contributed to by seventy-three households, making a total of \$7,325.00 in contributions. This fund was used for a variety of expenses, with the greater part being paid out for legal fees to our attorney (This money was remarkably well-spent, in the light of the fact that we stayed out of court and achieved our goals). We have a deficit of approximately one thousand dollars to meet on these fees. If you have not given to help yourselves and your neighbors, this is an excellent time to do it.

We have much to do if we are to prevent future developments of this kind. We have applied for the initial survey of a Historic Overlay Zone from the city, and we will begin to instigate back-zoning procedure on critical areas adjacent to us. These two courses of action are supported by City officials, who, I believe, have our future interests at heart.

On Sept. 30th the City Council, with ours and much other support voted 12-0 to recommend that no station be built at Hollywood Bowl. This came after
